Authorities seized nearly 21 500 bottles of adulterated liquor in total and discovered a clandestine factory where adulterated liquor was manufactured. Additional 21 228 bottles of adulterated liquor (total value 203 000 Euros), 5 000 bottles of contraband liquor (total value 30 700 Euros), and 10 000 units of adulterated alcohol were seized in other operations.

Counterfeit infant formula

QR code technologies are starting to bear fruit concerning food fraud detection. Software created in New Zealand helped to detect counterfeit infant formula that was supposed to be from Australia. Instead, the product was shipped from Russia and Singapore.

Nutritional declaration of infant formula was not compliant with sample research

In 2019, the Directorate General for Competition, Consumer Affairs and Fraud Prevention (DGCCRF) checked the nutritional composition and the quality of the nutritional declaration of infant formulas and follow-on formulas. The investigators checked 45 establishments (production stage, mass distribution, and the pharmaceutical circuit), and took 45 samples. For each sample, the technicians carried out 115 analyses concerning around 60 parameters (energy content, composition of macronutrients such as proteins and fats, and micronutrients such as vitamins and minerals). 8 out of 45 samples (18%) showed a minor discrepancy between the levels imposed by law and those identified. 36 out of 45 samples (86%) presented non-compliances in the nutritional declaration.
