#### Five supporting regulations published to accompany the new Organic Regulation 2018/848

Commission Delegated Regulation (EU) 2021/2304 of 18 October 2021 supplementing Regulation (EU) 2018/848 of the European Parliament and of the Council with requirements for the issuing of supplementary certificates intended for export certifying that antibiotics have not been used in the organic production of livestock products.
