MRL set for the antibiotic bambermycin in poultry

Regulation (EU) No 37/2010 lists pharmacologically active substances including their classification according to maximum residue levels (MRLs) in food of animal origin. Bambermycin is an antibiotic already authorised for use in rabbits. An application to extend its use in chickens has been submitted. The Commission has therefore asked the European Medicines Agency (EMA) to set MRLs for use in chicken meat. A distinction is made between muscle, skin and fat, liver and kidney. The EMA assessed that it is appropriate to extrapolate the MRLs set for chicken meat to all poultry species (excluding poultry eggs). The MRLs are set out in the annex to the regulation. The use in animals producing eggs for human consumption is not authorised.

The Canadian Food Inspection Agency (CFIA) is pressing charges as "part of the ongoing investigation into the alleged misrepresentation of organic poultry products." The agency declined to provide further details, citing the ongoing court process.

Researchers tested for antibiotics in urine from beef cattle whose meat was supposed to be labeled as raised without antibiotics (RWA). By using rapid immunoassay to detect 17 antibiotics on 699 animals, the authors found that 15% of analyzed cattle actually tested positive for at least one antibiotic.
